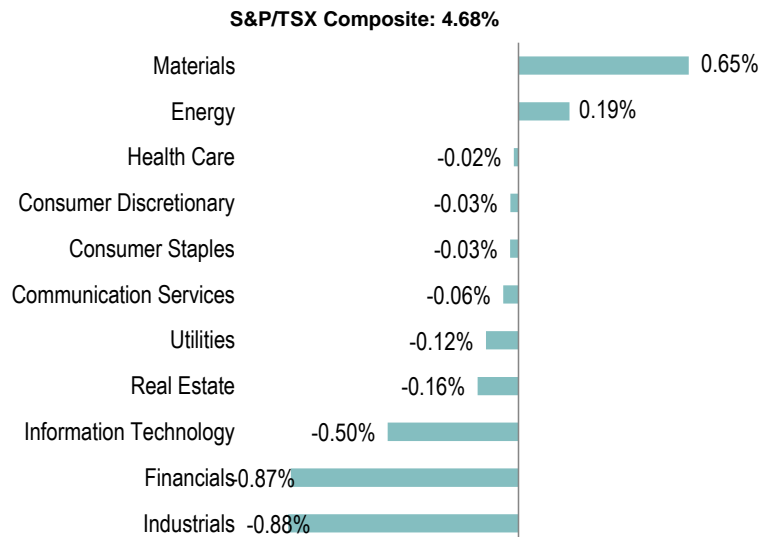

Summary

- Canadian equities finished the month on the downside. The S&P/TSX Composite and S&P/TSX 60 declined 1.8% and 2.2%, respectively.
- Canadian sectors posted mixed performance for the month, with Materials leading, up 5.9%, while at tail of the pack, Real Estate fell 6.8%.
- Among industries, the S&P/TSX Global Base Metals rose 7.7%, while the S&P/TSX Composite Industrials fell 3.6%.
- As growing concerns surrounding rising inflation and the resulting hawkish sentiment from the Fed led to market jitters, U.S. equities tumbled in April, with the S&P 500® down 2.5%.
- Mid and small-caps fared worse than their large-cap peers, with the S&P MidCap 400® and the S&P SmallCap 600® declining 4.5% and 4.1%, respectively.
